

3359-22-05 Contract professional grievance procedures.

(A) Preamble.

- (1) The university of Akron seeks to employ the most capable personnel to work together in pursuit of the university's goals of

- (2) The "CPGC" shall not substitute its judgment for the performance evaluation of the supervisor but ~~shall~~ may address itself to such charges as arbitrary, capricious, or ~~discriminatory~~ unreasonable action which violates the procedural or substantive rights of the complainant.
- (3) Actions related to discrimination and/or sexual harassment may be referred to the office of equal employment opportunity.

(E) Complaint Process.

- (1) In an effort to encourage the prompt, fair, and amicable solution of differences at the main point of origin, the contract professional should first discuss the problem w

- (b) The second level supervisor, within seven working days, shall respond to the complainant
- (c) If no response is given from the second level supervisor or if the complainant is not satisfied with the response, the complainant may, within seven working days, submit the complaint to the vice president, unless the vice president is the second level supervisor. If the vice president is the second level supervisor the complainant must submit the complaint to the "CPGC."
- (d) The vice president or the "CPGC," within seven working days, shall respond to the complainant.
- (4) ~~The complainant may need to proceed through a number of administrative offices before the level of vice president (or other appropriate chief administrative officer). Each decision shall be recorded in writing with copies to all parties involved.~~
- ~~(6) In the event that the complaint reaches the level of vice president within this period, all parties involved shall meet with this administrative officer to discuss the issues and review primary information and decisions recorded during each step prior to this administrative review. This officer shall render a decision in writing to the complainant within five working days following this meeting.~~
- ~~(7)~~(5) If the complainant is not satisfied with the decision at the vice president's level, or if the time period of ~~fifteen~~ thirty-five working days from the day the complainant first submits the written complaint to the immediate supervisor has elapsed with no decisions having been rendered, the complainant may then file a formal written grievance with the "CPGC" of the university of Akron.
- (F) Filing of grievance. Within seven working days after a vice presidential decision has been made, the complainant may submit a formal written grievance ~~may be submitted~~ to the chair of the "CPGC" with all pertinent

documentation of previous discussions, including a summary of the issue, the remedy sought and timeline of previous steps. ~~within five working days after the complainant receives a decision at the vice president's level, or within twenty days from the date the complainant first submits the complaint to the immediate supervisor if no decision has been rendered at the vice president's level.~~

- (1) The complainant will receive notification of "CPGC's decision within seven working days from the date that the grievance has been filed.
- (2) While the grievance will not generally be rejected merely because the administrative sequence has not been followed, the "CPGC" shall inform human resources of all such delays and the concerns, if any, caused by such delays.
- (3) The "CPGC" will inform human resources of the receipt of the grievance.

(G) Investigation of Grievance.

- (1) Within seven working days of receipt of the grievance, the chair shall appoint one or more committee members to meet privately with the complainant and one or more other committee members to meet privately with the party or parties against whom the grievance has been lodged. "CPGC" shall review the grievance to determine if it is within the "CPGC's purview and if the complainant process has been followed.
- (2) If the grievance is outside the "CPGC's purview, the grievance will be rejected. If the complaint process was not followed, the grievance may be rejected.
- (3) If accepted the "CPGC" has seven working days during which the chair shall appoint one or more committee members to meet privately with the complainant and one or more other committee members to meet privately with the party or parties with whom the grievance has been lodged.

~~(3)(4)~~ Within five working days, ~~The committee, in closed session,~~ shall then vote to ~~continue~~ uphold or reject consideration of the grievance. ~~This decision and supporting rationale shall be transmitted in writing to the parties and the respective vice president or other appropriate chief administrative officer.~~

(H) Disposition. The recommendations of findings and supporting rationale shall be transmitted in writing to the parties, the respective vice president, the president and the executive director of human resources. The president or designee shall inform the complainant and "CPGC" of any further action in the matter.

~~(I) Conciliation. Following a vote to continue consideration of the grievance, the "CPGC" may decide to form a conciliation subcommittee, consisting of the previously appointed investigating members and one additional committee member appointed by the chair of the "CPGC". Within five working days of the appointment of the conciliation subcommittee, it shall hold a meeting to which all parties to the dispute and the respective vice president or other appropriate chief administrative officer shall be invited in writing. At this meeting, which shall be informal in nature, the committee members shall attempt to aid the parties in achieving a voluntary resolution to their differences. In those instances where conciliation proves unsuccessful, within five working days of the conciliation effort, the complainant may reaffirm in writing to the chair of the "CPGC" a request that the "CPGC" continue with the grievance procedure.~~

~~(J) Formal review. The "CPGC" shall immediately review all information as previously submitted pertaining to the dispute and shall within ten working days complete its deliberation of the matter and submit recommendations to the president of the university with copies to the parties and to the respective vice president or other chief administrative officer. The president or designee shall inform the complainant and the committee of the decision of any action in the matter.~~
